Each participant of the camp, as well as his parent - legal representative, is obliged to sign the application form for the Camp, by which he automatically agrees to the terms of use of the camp.

The organizer of the camp is obliged to ensure the implementation of all conditions stated on the official site of the camp as well as on the payment offer.

The camp organizer is not responsible for a possible accident that may occur as a result of the participants not following the instructions of the trainers or camp officials.

The participant is obliged to report in advance if he suffers from chronic diseases, allergies or has suffered a serious injury that may affect his physical condition, otherwise the organizer is not responsible for possible consequences.

In case the participant cancels the camp or drops out during the camp, the organizer is not obliged to refund the camp fee.

EPIDEMIOLOGICAL MEASURES, COVID-19 AND CANCELLATION CONDITIONS

The organizer undertakes to respect and implement all epidemiological measures of the National Civil Protection Headquarters of Croatia at the time of the Camp without exception.
